Throughout the summer, College Summit runs four-day workshops for rising high school seniors. 25-30 College Summit staff and volunteers spend four days guiding 45-55 low-income students through the college transition process. Workshops are held on partner college campuses around the country for stretches of 3 to 7 weeks, a workshop occurring every Thursday to Sunday. With the help of volunteers, students will achieve five main goals. They will be able to complete a college common application, craft a personal statement, gain insight about the financial aid process, talk one-on-one with a college counselor, and learn how to positively influence their peers outside of the workshop.

The curriculum guides students through the college application process and assists them in career exploration and transitioning from high school to college. The curriculum is taught by an educator as a regular class with assignments such as personal statements, college lists, and the FAFSA. The curriculum also includes an online component called CSNav, a comprehensive high school, college and career planning portal. Specially trained educators collect data on student progress towards key milestones in the application process to tailor instruction appropriately.

The 2009 Educators' Academies (EA) were designed to prepare teachers and counselors to implement College Summit successfully with a focus on the quality of instruction in the College Summit classroom. Planning for the 2009 EA was driven by recommendations from last year's training as well as by research conducted by College Summit's Education Department in the fall of 2008. In studies with College Summit students and partner educators our Research and Development team found that the quality of the instruction in College Summit classes matters to students more than any other tool in the College Summit arsenal. This finding is consistent with the education literature that focuses on teacher quality as a critical variable in student performance.
